# West African International Justice – Leadership, Challenges, and Opportunities

21 - 22 March 2019

# Accra, Ghana

West Africa has been the scene of impressive activity in the fight against impunity for international crimes. While other regions of the world are often the focus point for interested observers of international criminal justice, the engagement with justice and accountability processes in West Africa deserves scrutiny in its own right.

Since the establishment of the Special Court for Sierra Leone in 2002, the West African region has experienced a bourgeoning interest in justice for international crimes. In 2015, the Extraordinary African Chambers put the former President of Chad, Hissène Habré on trial for atrocities committed during his rule. At the same time, the International Criminal Court has been an involved actor in the region. It has opened investigations in the Ivory Coast and Mali. These investigations have yielded numerous trials, including that of former Ivorian President Laurent Gbagbo who was recently acquitted for crimes allegedly committed during the 2011 post-election violence in Ivory Coast, and that of a Malian Islamic extremist, Ahmad Al Faqi Al Mahdi, for the destruction of shrines and heritage sites in Timbuktu. It also has opened preliminary examinations in Guinea, and Nigeria where many believe it has helped to spur local investigations and prosecutions. Other states in the region, including Liberia and The Gambia, are considering their own, custom-made justice and accountability processes.

But West Africa has not just been the locus of activity in the investigation and prosecution of human rights violations and international crimes; it has also contributed significantly to the development of international criminal justice. Trials and prosecutions in the region have made an indelible impact on issues such as the prosecution of sexual and gender-based violence crimes, the linkages between international and transnational crime, the hybridization of international and national law and practices within tribunals, the conscription and use of child soldiers, etc.

In order to examine and explore the contributions and ongoing challenges facing West Africa in the fight to achieve meaningful justice and accountability for atrocities in the region, the Wayamo Foundation, the Africa Group for Justice and Accountability (AGJA), in collaboration with the Konrad Adenauer Stiftung's Rule of Law Programme for Sub-Saharan Africa and with the support of the Kofi Annan International Peacekeeping Training Centre and the School of Law of the Ghana Institute of Management and Public Administration (GIMPA) will hold a symposium on 21 and 22 March 2019, under the banner of "West African International Justice – Leadership, Challenges, and Opportunities". During this one-and-a-half-day conference, international and regional experts will critically assess the contributions of West Africa to global justice and the continuing challenges of achieving justice for atrocity crimes.
