n Friday, 8 March 2024, the Wayamo Foundation and the Prosecution Training Institute will be holding a one-day mock trial based on a fictional set of circumstances, designed to test the application of universal jurisdiction for international crimes in Kenyan courts. The mock case will examine the provisions of the International Crimes Act No.16 of 2008 and explore its applicability to situations where neither the perpetrator nor victims have Kenyan nationality, and the alleged crimes have not been committed on Kenyan territory.

The mock trial will bring together preeminent international and Kenyan judges and prosecutors who will guide the audience through some of the thornier issues facing lawyers seeking to apply international law domestically. The aim is to make the International Crimes Act more accessible and actionable for the Kenyan legal practitioners in the audience. Time has been set aside for a spirited question and answer session on conclusion of the trial.
